

 - A: Yes, document compare will be available before filing submission.
- Q: Will you be able to save the document compare results?
 - A: You will not be able to save document compare results with this implementation, but we will put this on the feature wishlist.
- Q: Is the document compare like Adobe?
 - A: Yes, it is similar functionality that will occur within SERFF.
- Q: Will document compare only be for pdfs?
 - A: There are other file types that will be implemented, but Excel is not supported, so the primary use in SERFF will be pdf to pdf.

- Q: Will document compare replace side-byside requirements?
 - That is not our decision. It will be up to the states whether they change their policies regarding side-by-side requirements to replace them with document comparison.
- Will we be able to compare documents from two different filings?
 - Not with the initial implementation, but that is on our agenda.
- When will the document compare feature become available?
 - We are estimating early to mid December.
- Q: Will we be able to have multiple effective dates on a filing?
 - A: We will add that idea to the feature wishlist.






What type of user are you?





How often do you use SERFF?







We use it when inquiries come in, those are routed to the areas that requested the filing be made. Document Review, Share filings.

To share forms lists with programmers, to share filings for audit purposes or to answer other questions internally.

Beyond keeping a permanent record outside of SERFF, how are you using PDF Pipelines?

Consolidating documentation in the course of filing review; Simultaneously searching specific documents with Ctrl+F;Document creation for enforcement referrals.

Rate Transparency posting to website

Pipeline during regulator filing review in order to search across document quickly for key concepts/sections (cancellation, terrorism, punitive damages, etc)

Sharing, teaching, record keeping purposes

Depending on what clients are looking for they can be referred to public portal.

Share win Non-SERFF users

Compare documents

Occasionally adding documentation to a filing that was made because older filing was in accessible due to consultant change or other change of ownership



Beyond keeping a permanent record outside of SERFF, how are you using PDF Pipelines?

Using PDF Pipeline to compare PDF copies of prior filings to new new filings, or filings for other states, for accuracy as part of quality control audits. To create a PDF of all forms that I save and use Adobe to make notes on during my review

For training purposes - to show others how to use it and its benefits

search for terms or phrases

viewing documents that might not open within the SERFF application

To review the entire filing. Not all documents received are required documents.

To send for guidance, legal opinions. Public record requests; sharing filing information with other divisions when needed for complaints, etc.

Publishing ACA rate filings to website

To search through specific attachments using CTRL+F



Beyond keeping a permanent record outside of SERFF, how are you using PDF Pipelines?

Email portions of a filing, if needed.

Checking on whether there are rates showing on a form filing and forms showing on a rate filing. Not acceptable in our state but this cloning issue shows in pipeline but not in the filing itself.

Share documents outside of SERFF - portions of filings rather than using SFA or direct access by state(s)

Research - adobe terms and phrases

F/U on document compare....how soon will we be able to compare across filing submissions. Industry doesn't always provide redlines
